The undersigned HANDLER acknowledges that there are no refunds after the first night of any scheduled group class.

Until such time as COVID restrictions are eased and communicated to DOCOH by the Town of Davie, the undersigned Handler shall review DOCOH's COVID-19 Guidelines and shall execute and deliver a COVID-19 Waiver to DOCOH prior to joining any class.
