MINUTES OF THE JUNE 21, 2021, ZOOM GENERAL MEETING

This is our Eleventh General Meeting via Zoom, and they are going well.

Reports of the Officers:

President's Report – Alyson Casper reported on the 6/21 Delegates Meeting. She recapped several items of interest to the Delegates and to the Fancy. Among these was that the AKC is recommending all clubs name a Junior Coordinator to develop Junior programs. There is also an AKC Canine Preservation Bank which preserves sperm for all breeds and especially for low entry breeds.

Agility – Annette Smith gave the report in place of Jeff Greiff. There is to be a car race on 11/5-6-7 at our usual venue in Ft. Pierce. Consequently, we cannot hold our trials. In their place an ACT I and ACT II (Agility Course Test) may be held. These tests are for beginner dogs.

Old Business:

Trainer's Meetings - Stacy coordinated two trainers' meetings. The outcome is the following:

It was proposed that the Club will pay for CGC/STAR Puppy certification for instructors—Janis Neff, Annette Smith, Carol Ann Klein, Kathleen Keyte, Stacy Santarone, and Helen Shillington. Cost is approximately \$100 each.

There is to be a Drill Class starting each month. The same instructor will teach for the month. The drill portion will run for 3 weeks, and the 4th week will consist of a new subject, i.e., Tricks, or other fun class.

It is planned that there will also be 3-week Rally classes with Video taping on the 4th week to send to AKC for virtual titles.

A CGC class will start 7/13. Stacy, Kathleen, and Tina will apprentice.

Gretchen Brown will be asked if she wants to conduct a conformation class at the Area during our training times.

A new schedule is being prepared by Stacy.

Life Members – the club will have made a \$100 donation in memory of Harryette Smith to German Shorthaired Pointer Rescue. Additionally, Jean Lunsford and Jana Smith have passed. It was voted that \$100 each will be sent to Huntington's disease Society of America (Jean) and Therapy Dogs International (Jana).
